The International Conference on GPP aims to consolidate itself as a meeting place for professionals from government, academia, the private sector and NGOs.

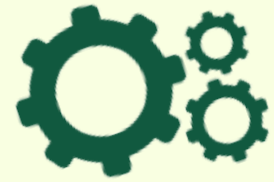
The event offers participants the opportunity to understand the current situation, update their knowledge and share best practices, as well as to explore future perspectives for Green Public Procurement.
