## About the conference

A meeting of experts in public procurement with an interest in climate change

The 1st International Conference on Green Public Procurement aims to offer an interdisciplinary analysis of ecological public procurement in light of the European Green Deal and recent legislation on climate change and energetic transition.

The event will focus particularly on the food and construction sectors, both being responsible for high levels of energy consumption and greenhouse gas emissions.

This conference has been organised by the “Green Public Procurement” Research Group based at the University of Alcalá (Madrid, Spain) in collaboration with other researchers and experts in public procurement. It forms part of Research Project UAH CCG20/CCSJ-015, “An industry-based analysis of Green Public Procurement and climate change: the construction and food sectors.”, which is funded by the Department of Research at the University of Alcalá in the category, “Projects which promote the creation and consolidation of Research Groups”.

A number of other activities have taken place as part of this project including three forums on food sustainability (December 2020) and two seminars on construction and public procurement (April 2021), and on construction, certified timber and public procurement (June 2021).

The International Conference on GPP aims to become a meeting place for professionals from government, academia, the private sector and NGOs.

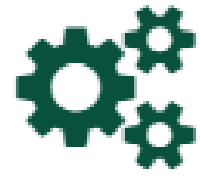
The event offers participants the opportunity to understand the current situation, update their knowledge and share best practices, as well as to explore future perspectives for Green Public Procurement.

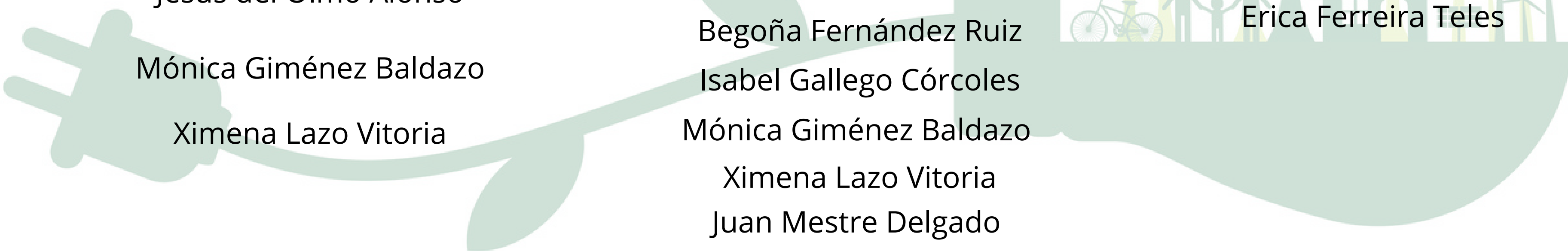

# PAPERS

Consult the guidelines for submitting a paper

Papers may be submitted for any of the presentations and round tables taking place at the 1st International Conference on Green Public Procurement. The deadline for submissions is 14 th October 2021.

The Conference's Scientific Committee will review the papers received and decide if they are to be accepted. A selection will then be made from the approved papers to be delivered orally.

The main content of the paper must be presented in a maximum of five minutes. The authors of accepted papers will be notified by e- mail.

The text of all papers must meet the following key requirements:

- Prepared in Word format
- Maximum of 10 pages long
- Times New Roman 12-point font (footnotes in 10 point)
- 1.5 line spacing
- 2.5cm top and bottom margins

Required layout for the content of papers:

- Title of the paper
- Author
- Occupation/university/government/department/company
- Summary (max. five lines) stating the aim of the paper
- Final conclusions
